Overview

Jyoti Mittal represents employers primarily in the defense of wage and hour class, representative, mass and single actions. - Obtained ruling denying class certification of all claims in a wage and hour class and representative action against a large healthcare provider, paving the way for a favorable settlement of claims

- Defended hospital clients in wage and hour class actions regarding missed meal and rest periods and other wage payment issues

- Tried and resolved numerous cases before the California Division of Labor Standards Enforcement involving wage and hour disputes
