Overview

Adriana Foreman represents and advises employers in a broad range of labor and employment matters, including front-end compliance, internal investigations, and litigation. She advises employers on employment issues related to reductions in force and other business restructuring and downsizing matters, including compliance with federal and state Worker Adjustment and Retraining Notification (WARN) Acts and the Older Workers Benefit Protection Act (OWBPA). In addition, she performs preacquisition due diligence for corporate clients and private equity firms to identify employment obligations and liabilities that may impact the value and structure of a corporate transaction.

Prior to joining Littler, Adriana worked at a global law firm as part of the firm's financial restructuring and insolvency group. Her practice focused primarily on corporate bankruptcy and restructuring matters, including the representation of debtors and creditors in Chapter 11 proceedings.
